- 2. No pre-cooking or outside meats. Meat bundle provided by Legendary Waters Resort & Casino includes:

WHOLE CHICKEN | PORK RIBS | BEEF BRISKET (Garnish items not provided in meat bundle.)

- 3. You are allowed to bring your own seasoning and garnish items.
- 4. Only wood and charcoal cookers allowed. No exceptions.
- 5. Must follow competition schedule:
 - a. 8:00 a.m. Legendary BBQ Battle cook start.
 - b. 4:00 p.m. Turn in CHICKEN samples for judging.
 - c. 5:00 p.m. Turn in PORK samples for judging.
 - d. 6:00 p.m. Turn in BEEF samples for judging.
- 6. Judging Criteria:

TASTE | TENDERNESS | APPEARANCE | SMOKE RING

7. Judge Sample:

Prepare a minimum of 3 samples. Turn in times listed above (Rule Number 5). Plastic or paper sample cups will be provided by Legendary Waters.

8. Complete and sign General Liability Release Agreement (Hold Harmless).
